Ms. Euler advised there had been two (2) items on the Closed Agenda and on the first item Council received a Presentation from Red Brick Communications as part of Council Education. She advised Council would be returning to a Closed Session following the Open Session to deal with the second item.

9. Presentations

a. Ms. J. Pyzer of BDO re 2021 Audited Financial Statements.

Ms. Pyzer presented the 2021 Audited Financial Statements to Council. Mr. Landsdell-Roll advised that the city does not budget for a surplus and that the budget actually balances. He noted there will be some differences as the auditors reflect amortization in their figures. Mayor Wilson asked how long it will take for the HST rebate that was received in 2018 to officially be the City's. Ms. Pyzer advised it usually takes between 7-10 years. Councillor Carlucci asked if there was any interest being charged on the received amount. Ms. Pyzer was unsure but advised that they would file a fairness ruling or something similar if interest was to be charged. Councillor S. MacKinnon asked about the variance in reserve funds in sewer and waterworks from 2020 to 2021. Mr. Lansdell-Roll noted that it was not a variance but actually a change in balance. Ms. Pyzer finished her overview of the Financial Statements and was thanked by Mayor Wilson.

b. CAO R. Nesbitt - 2021 Year End Report.

Mr. Nesbitt presented the 2021 Municipal Annual Report for the City of Dryden. He noted that none of the accomplishments made through 2021 would be possible without hard work of all City staff and Council's support. Councillor S. MacKinnon shared praise for Mr. Nesbitt and City staff for being able to adapt to unforeseen circumstances and for protecting residents as well as other communities. Councillor

Carlucci thanked Mr. Nesbitt and his staff for all that they do for the City of Dryden. Mayor Wilson asked for an update on what is happening to the Recreation Centre in 2022. Mr. Nesbitt advised that the Recreation Centre upgrades are ongoing and there is an expansion that was planned for next year that may start earlier. Mr. Belanger noted that there is an upcoming project to upgrade the Arena glass as well as several large pieces of mechanical equipment.

19. Staff Reports

a. Economic Development-2022-004 NOHFC Funding Application Resolution -Economic Development Manager.

Mr. Peacock presented his report recommending that Council authorize staff to complete an application for the City of Dryden to contribute \$129,297 to the Northern Ontario Heritage Fund Corporation (NOHFC) Community Enhancement Program for trail redevelopment and enhancement as recommended in the 2022 Trails Feasibility Study. Mayor Wilson asked if there were any anticipated alterations to the submission due to high water levels. Mr. Peacock advised that it is currently not known if the high-water levels will have any effect on the project and that the city will reassess the situation when the water recedes. Mr. Nesbitt shared that the project timeline will have to be extended but the funding application should not be affected. Councillor S. MacKinnon asked if there will be future funding applications for additions to the trail system in this funding application and future funding applications will be submitted based on recommendations presented in the Trails Feasibility Study.

Ms. Euler presented her report on Council Remuneration, providing several options for Council to consider. Councillors Price and Carlucci advised that the increases based on comparators are too high and that they'd support a small increase only. Councillor McKay asked if the next Council could make the decision on the increase. Mayor Wilson advised that having this Council make the decision eliminates a conflict of interest. Councillor M. MacKinnon shared that a small increase is the most he could support. Councillor S. MacKinnon concurs with all other Councillors. Council supported a small wage increase tied to the non-union salary grid increase starting in 2023 and directed a by-law be brought forward to a future Meeting of Council.

22. Reports of Municipal Officers

a. CAO

Mr. Nesbitt gave an update on the water level situation around Dryden, noting that the Public Works department is monitoring things on a daily basis. He advised that both of the boat launches in Dryden are currently closed for the protection of municipal property and public safety. Mr. Nesbitt noted that there will be substantial Highway 17 paving and patching happening very soon. He also advised that the Community Capacity and Business Gap Analysis reports will be out to Council in June. Lastly, Mr. Nesbitt noted that the Age Friendly report should be ready to present in June or July.

b. Treasurer

Mr. Lansdell-Roll advised that any items included on the Management Letter from the Auditor's Report will have a staff report next month for presentation to Council. He also noted that he will be presenting a staff report in June with a budget amendment relating to the prior year's surplus.

c. Clerk

Ms. Euler gave an update on the status of the Municipal and School Board Elections. She gave a reminder that nominations are to be filed with the City Clerk by 2:00 p.m. on August 19th. Ms. Euler advised that she has begun planning Council orientation for the next cohort and gave an update of the other projects the Administration department has been working on.

d. Public Works Manager

Mr. Poole gave an update on the high-water situation in Dryden. He thanked the engineering technologist for the City of Dryden for monitoring infrastructure. He also thanked the Public Works staff for coming in on weekends for sandbagging activities, Domtar for providing critical information to the city and the Ministry of Transportation for providing bridge inspectors to monitor critical infrastructure. Mr. Poole also noted that bridge inspections are planned for this year. He advised the city is still closely monitoring our infrastructure. Lastly, he noted that the Highway 17 paving project will begin shortly, and the city traffic light project has begun.

e. Manager of Community Services

Mr. Belanger advised that the Sandy Beach and Rotary Park soccer complexes are both open for programming and he thanked all the volunteers who organize and manage those programs. He also gave an update on which sports are starting soon and which have already begun in the community. Mr. Belanger advised that Aaron Park opened successfully over the past weekend. He also gave an update on the expansion of the Dryden Memorial Arena and advised that there is a Dryden Dog Park fundraising event coming up on June 12th, 2022 in the parking lot of the Rotary Park Soccer Complex which will include a vendor's market. Lastly, he noted they have begun to change over to a new dehumidifier at the Dryden Pool and his department is currently working on planning events for Canada Day and Indigenous People's Day.

Councillor Price gave a reminder of the Tagged Fish Contest that is put on by the Dryden Trailblazer Tourism Association (DTTA) and that tickets can be bought at Clark's, QSL Tackle and Bonny Bay Camp. She also noted that Dryden Days of Summer will be starting near the end of June and that Patricia Area Community Endeavours (PACE) has started an incubator program.

Councillor S. MacKinnon congratulated Karen Hamilton on her recent retirement. He also noted that the Provincial Election is coming up before the next Council meeting and he urged everyone to get out and vote.

Councillor M. MacKinnon gave kudos to Mr. Lansdell-Roll, Ms. Pateman and the finance department for their audit report and financial statements.

Councillor McKay agreed with Councillor M. MacKinnon about the audit report.

Councillor Carlucci gave kudos to Mr. Nesbitt, the Public Works department and City staff for their efforts in dealing with the high-water levels in the area.
