

THE CORPORATION OF THE CITY OF DRYDEN

BY-LAW NUMBER 2022-41

BEING A BY-LAW TO DELEGATE AUTHORITY TO THE CAO FOR CERTAIN ACTS DURING A RESTRICTED ACTS OF COUNCIL PERIOD.

WHEREAS Section 270 of the Municipal Act S.O. 2001, as amended, requires, in part, that at municipality adopt and maintain policies with respect to the delegation of its powers and duties and hiring of employees; and

WHEREAS Section 275 of the Municipal Act S.O. 2001, as amended imposes restrictions on the actions that a Council can take during the election of a new council, specifically relating to the following actions:

- (a) the appointment or removal from office of any officer of the municipality;
- (b) the hiring or dismissal of any employee of the municipality;
- (c) the disposition of any real or personal property of the municipality which has a value exceeding \$50,000 at the time of disposal; and
- (d) making any expenditure or incurring any other liability which exceeds \$50,000; and

WHEREAS Section 275 (6) of the Municipal Act S.O. 2001, as amended states that nothing in Section 275 prevents any person or body from exercising any authority of a municipality that is delegated to the person or body prior to Nomination Day for the election of the new council; and,

WHEREAS Council deems it expedient to delegate authority to the CAO during the restricted acts of council period in order to maintain business continuity,

NOW THEREFORE the Council of The Corporation of The City of Dryden enacts as follows:

1. That the Council of the Corporation of the City of Dryden hereby delegates authority to the CAO to:
 - (a) appoint or remove from office any officer of the Corporation (with the exception of Statutory Officers).
 - (b) hire or dismiss any employee of the Corporation (with the exception of Statutory Officers).
 - (c) dispose of any real or personal property of the Corporation which has a value exceeding \$50,000.00 at the time of disposal; and
 - (d) make any expenditures or incur any other liability which exceeds \$50,000.00.
2. That the CAO will submit a report to Council advising of any events relating to the exercising of these delegated powers.
3. This By-Law is and shall remain in force and effect upon from Nomination Day up to and including the date of the commencement of the new term of council.
