 a. Finance-2023-022 Amendment to the 2023 Budget – August 2023 -Treasurer.

In response to a question from Councillor Price, Mr. Lansdell-Roll advised that the Gator that is being replaced is around 30 years old. Councillor Noel asked for clarification on what the Water and Sewer project on Claybanks Road is. Mr. Lansdell-Roll advised that it would be to extend water and sewer service to Claybanks Road and noted that the project is not part of the 2023 Capital Plan but it is being kept in mind. In response to a question from Councillor Tardiff, Mr. Lansdell-Roll advised that the City's Procurement Policy requires 3 quotations and that 3 were received for the Gator. Mr. Nesbitt noted that a 4th quote had been received last minute. A by-law to amend the Capital Plan will be brought forward to the August 28 meeting of Council.
