NOMA Board Meeting Summary Report for June 3, 2024

Regional Economic Development in Canada

Sarah Lewis & Paul Blais, and Evelyn Paul from Deloitte presented on what is being worked on across Canada in regard to economic development. Collective hope for economic development moving forward in region. Can share presentation on request. Discussed NOMAs Time to Grow Plan and its focus on workforce, infrastructure and leveraging advocacy. Plan to set the framework for what's coming and addressing issues that have been prevalent.

Northwestern Ontario IEHP Program

Dave Johnson provided a presentation on the Northwestern Ontario Internationally Educated Health Professionals (IEHP) Program. The NOMA board to provide a letter of support.

Eastern Ontario Warden's Caucus 7 in 7 Regional Housing Project

Peter Emon provided a virtual presentation regarding Eastern Ontario Warden's Caucus 7 in 7 Regional Housing Project. NOMA board supported this project and will send a letter of support. Peter noted that this project could be replicable in other areas in Ontario. Can share presentation on request.

Rural Communities Immigration Program

Jamie Taylor from CEDC provided a verbal update on the new program. Two new pilots for rural and francophone minority communities launching Fall 2024, the Rural community immigration pilot (RCIP) and Francophone community immigration pilot (FCIP). There are 2 options: one that's geographic boundary is the whole NW region (with 2-3 CEDC individuals representing the whole region) or Thunder Bay CMA (1-2 individuals which will focus on community integration with Thunder Bay). After 5-year pilot they do plan to make it permanent. Letters of support will be needed to move forward with option 1 for the whole of the NW. However, currently unsure if option 1 is eligible through this pilot. Will determine by next week when hear back from IRCC. NOMA to send letter to IRCC to get clarity and support option 1. Will provide letter of support to municipalities once confirmed.

Fair Funding Model for Northern Ontario Resource-Based Communities

NOMA supported the resolution passed by the City of Timmins regarding Fair Funding Model for Northern Ontario Resource-Based Communities. (attached)

Letter of comment to the Ontario Energy Board

NOMA to send a letter of comment for Enbridge's rate rebasing case: Phase Two to secure access to natural gas for Ontario's future. A copy of this motion to be sent to the Minister Smith of Energy, Minister Pirie of Mines, Minister Greg Rickford of Northern Development and Indigenous Affairs, MPPs, and all municipalities. Be Spatial 2024 Event

Be Spatial held an event in Thunder Bay on June 4th and were seeking our partnership. Unfortunately, timing did not allow for this to work this year. However, they are interested in partnering in 2025. ED will provide information when it becomes available for next year.

Approval of "Time to Grow" – NOMA Regional Economic Development Plan

NOMA board approved "Time to Grow" – NOMA Regional Economic Development Plan with one minor correction. (Please see and share plan attached.) NOMA to bring forward this plan at the AMO Conference for a multi-minister delegation. The second topic for our AMO multiminister delegation is to create a framework to ensure unorganized organizations in Northwestern Ontario and across Ontario pay for their share for the services they use. Ex. Greenstone gold mine will be up in May and they do contribute to taxes as they are within greenstone boarders.

NP Billing Numbers

Nurse Practitioner billing is currently part of hospital funding. Most other health care practitioners have a billing number. A discussion occurred and the Board decided to send a resolution in the form of a letter to Minister Sylvia Jones and MP and all municipalities. NOMA to provide a letter to Minister Jones to secure billing numbers for Nurse Practitioners to bill services provided. Letter to be sent to NOMA municipalities to provide letters of support. (Will send out separately once completed.)

Fort Frances Resolution – American Fishing Guides & Anglers in Canadian

Minister committed to working on this at the NOMA Minister Forum.

Executive Director Report:

- NOMA Conference was a tremendous success with over 350 guests in attendance, 132 of which were delegates. We had 22 sponsors, 31 exhibitors, and over 50 presenters. A donation of \$3500 was made to the RFDA in lieu of speaker gifts.
- Have been in discussions with FEDNOR, NOHFC, and others to acquire funding for a regional economic development coordinator for the Northwest in order to facilitate the NOMA regional Economic Development Plan "Time to Grow".
- Alliance & NOMA met with Minister Smith at the NOMA Conference on April 25th to discuss state of forestry and pulp and paper mills, forest road access, biomass, energy, and caribou. Minister Smith is a strong supporter of the forestry industry and is working to address the loss of the AV Terrace Bay Mill.
- Met with Pollution Probe with Iain Angus. They have received funding through the OEB to develop a framework to inform a variety of groups including municipalities on what they need to consider in order to achieve net zero targets by 2050. Their focus is rural and remote communities in Ontario and low carbon innovations. Over the next year they plan to meet with communities and stakeholders to inform the work and release the framework June 10th, 2025. ED will assist them to coordinate a municipal workshop in the North. A NOMA rep to also sit on their advisory committee that will meet 2-3 times for approx. an hour.
- Independent Electricity Systems Operator (IESO) is recruiting potential members to submit a nomination to join the IESO's Strategic Advisory Committee. The IESO's Strategic Advisory Committee provides appointed representatives with the opportunity to provide timely advice and feedback to our Board of Directors and Executive Leadership Team on a wide variety of topics and issues related to the current and future state of Ontario's electricity system, as well as the energy transition.

Energy – Jim Vezina reported CVNW has dissolved. Jim had meeting with Lise Vaugeois to explain energy issues in the region.

Housing – Kristen Oliver reported Canada and Ontario have created a joint housing strategy. **Fire/EMS/Police –** Eric Pietsch to take lead on newly added tracker item.
