4. Disclosure of Pecuniary Interest and the general nature thereof for the agenda for this meeting

Chair Councillor M. MacKinnon called for declarations of pecuniary interest, and the general nature thereof, under The Municipal Conflict of Interest Act with respect to the agenda for this meeting and the response was negative.

5. DRAFT Dryden, Machin and Area Community Safety and Well-Being Plan: Presentation to the Councils and Public

a. MNP LLP, Consultant.

Ms. K. Jaeger provided background on the Joint Community Safety and Well-Being Committee and then introduced Mr. R. Catte of MNP LLP. Mr. Catte advised that Bill 68, the Comprehensive Ontario Police Services Act, 2019 requires municipalities to develop a Community Safety and Well-Being Plan (CSWB Plan). He stated a CSWB Plan is to address areas such as education, mental health, addictions, food security, housing, crime and violence and to ensure healthy and vibrant communities. It helps agencies and community groups work together to respond to issues more effectively and to develop innovative ways to improve the lives of residents. He noted the CSWB Plan must be developed in partnership with a multi-sectoral advisory committee, such as the Joint Community Safety and Well-Being Advisory Committee, that includes, at a minimum, representatives from a specific set of community agencies and service providers.

Mr. Catte reviewed the list of Joint Advisory Committee representatives and noted the the Joint Committee is supported by four (4) Pillar Working Groups: Supporting our Youth Pillar, Prevention/Education Pillar, Treatment Pillar and Social Development Pillar. Mr. Catte advised the Mission of the CSWB Plan is "We will bring people together to advance inclusion, build upon our resilience, and strengthen our community connections for a safer Dryden, Machin and Area." He reviewed the Plan's Guiding Principles and Objectives before discussing Implementation, Tracking Progress and Next Steps. The CSWB Plan is to be adopted by the City of Dryden and Municipality of Machin and then the Pillar Working Groups will finalize implementation plans and key performance indicators to monitor the progress of the Plan moving forward.

Councillors thanked Mr. Catte and the Committee for their presentation of the Plan. Councillors and Committee members discussed the age range for "youth" as set out in the Plan and consideration of a Youth Centre in Machin.
