## **THE CORPORATION OF THE CITY OF DRYDEN**

## **BY-LAW NUMBER 2022-1**

BEING A BY-LAW TO AUTHORIZE THE EXECUTION OF AN AGREEMENT BETWEEN HER MAJESTY THE QUEEN IN RIGHT OF ONTARIO AS REPRESENTED BY THE SOLICITOR GENERAL AND THE CORPORATION OF THE CITY OF DRYDEN FOR THE PROVISION OF POLICE SERVICES WITHIN THE CORPORATION OF THE CITY OF DRYDEN.

- WHEREAS Section 9 of the *Municipal Act, 2001, S.O. 2001, c.25*, as amended, provides a municipality with the powers of a natural person for the purpose of exercising its authority under this or any other *Act*,
- AND WHEREAS Section 5 of the *Police Services Act, R.S.O. 1990 c. P. 15*, as amended, permits a municipality to discharge police services by entering into an agreement under Section 10 to have police services provided by the Ontario Provincial Police;
- AND WHEREAS Section 10 of the *Police Services Act, R.S.O. 1990, c P. 15*, as amended states the Solicitor General may enter into an agreement with the Council of a municipality for the provision of policing services for the municipality by the Ontario Provincial Police;

NOW THEREFORE the Council of The Corporation of The City of Dryden enacts as follows:

- 1. THAT The Corporation of The City of Dryden accepts the Ontario Provincial Police Contract Policing Proposal dated December 12, 2021.
- 2. THAT the Dryden Police Services Board, the Dryden Police Service and the City of Dryden Chief Administrative Officer are authorized to take the necessary steps to implement the transition and amalgamation of the Dryden Police Service with the Ontario Provincial Police.
- 3. THAT the Mayor, Clerk and Chief Administrative Officer are hereby authorized to execute any documents or agreements required to implement and finalize the transition and amalgamation of the Dryden Police Service with the Ontario Provincial Police within the scope and in accordance with the Ontario Provincial Police Contract Policing Proposal dated December 12, 2021.
- 4. THAT this by-law shall come into force and take effect on the final passage hereof.
