a. Staff Report Public Works-2021-04 re Waterworks Report - Water Works Manager.

Mr. Walker presented his Staff Report recommending Council endorse the Drinking Water Quality Management Standard (DWQMS) Operational Plan. He provided Committee with an update of the ongoing activities of the City of Dryden Waterworks Department. Staff were directed to bring a motion to the next Meeting of Council on December 13, 2021.

b. Staff Report Finance-2021-14 re Water and Sewer Rate Increase - Treasurer.

e. Staff Report Administration-2021-36 re OPP Detachment Board Composition - CAO.

Mr. Nesbitt presented his Staff Report recommending Council confirm the composition of the new OPP Detachment Board and direct the CAO to complete the Proposal Form and submit the City's proposal to the Ministry of the Solicitor General. Staff were directed to proceed with the completion of the proposal form indicating the board size be kept at the minimum number of board members which is five (5) and to submit it to the Ministry of the Solicitor General.

f. Staff Report Administration-2021-37 re COVID-19 Workplace Vaccination Verification Policy - CAO.

Mr. Nesbitt presented his Staff Report recommending the implementation of a COVID-19 Vaccination Verification Policy requiring proof of vaccination in the workplace, including a comprehensive testing, education and communication plan for unvaccinated staff; and that the COVID-19 Vaccination Verification Policy applies to all City employees, including full-time, part-time, permanent, temporary, casual, students, term-contract and volunteer fire fighters; and Council provide direction to City staff regarding the inclusion of members of City Council, members of Council Committees and volunteers under the City's COVID-19 Vaccination Policy. Staff were directed to revise the Policy to include members of Council, Committees and volunteers in the City's COVID-19 Vaccination Verification Policy and to bring a bylaw forward to the next Meeting of Council on December 13, 2021.
